### EXHIBIT "A"

Article II, Section A(2) of the CC&Rs shall be amended in its entirety to read as follows:

2) Membership based upon ownership of a Unit with each Member having one\*(1) vote for each Unit owned by such Member. Cumulative voting in the election of directors shall not be permitted. In any election of directors, every Member entitled to vote shall have the right to cast the number of votes equal to the number of directors to be elected, multiplied by the number of votes to which the Member is otherwise entitled. Each Member may distribute these votes among the candidates for director in any manner he deems appropriate, provided that not more than one (1) vote may be cast for any one candidate. Not withstanding anything to the contrary in this Declaration, the candidates receiving the highest number of votes up to the number of directors to be elected shall be elected. In the event of a tie between or among the candidates running for the remaining vacancy or vacancies on the Board, a run off election shall be held between or among these tied candidates. In the run-off election, the candidate or candidates receiving the highest number of votes up to the remaining vacancies being contested shall be elected."
